How Did You Hear About Us?

- The student will receive 10 hours of classroom training and 6 hours of behind the wheel training for the state minimum driver-training course. Student must complete all hours of training to receive completion certificate. Replacement certificate - \$10.00.
- Tuition for the state minimum driver-training course is \$395. Tuition must be paid in full on or before the first day of class. Pay As You Go Driver's Ed is available for a total of \$425 with \$125 being paid on the first day of class and \$100 for each of the three, two hour drives. **The tuition for this course is NON-REFUNDABLE. Insufficient check fee: \$50.00 furthermore I agree Cowboy Driving Academy may process my check electronically.**
- Parents are responsible to drive with their students 50 hours before their student can take the drive test (under 18). We are able to do as much as you prefer. Additional packages beyond state minimum requirements are available for a discount on cowboydriving.com.
- Cancellation of drive and test times must be made at least 24 hours before scheduled drive or test. **STUDENT WILL BE CHARGED \$50.00 FOR CANCELLATIONS NOT MADE BEFORE THE 24-HOUR PERIOD - NO EXCEPTIONS.**
- Parents and/or legal guardians must inform Cowboy Driving prior to class of any medical, physical or mental health problems which could directly relate to student performance in any aspect of the courses to be provided by Cowboy Driving Academy (ADHD, asthma, contact lenses, diabetes, epilepsy, hearing difficulty, paralysis, etc.) Failure to divulge this information could be considered negligence.
- TESTING FEES:** TESTING ONLY IN Cowboy Driving Academy CERTIFIED CAR. FEES ARE DUE AT TIME OF TEST. Forth (4th) DRIVE & TEST - \$150 (\$25 for State Road Test, \$25 for use of Cowboy Driving Academy Car and \$100 for hour of prep. RE-TESTING - \$25 for State Road Test & \$25 for Car Rental.
- TURNKEY PROCESSING** (if not included in the package you purchased): After passing drive test, Cowboy Driving Academy will transport student to DPS and/or Tag Agency. Once processing is completed, CDA will transport student to home, work or school. Fee is \$75 (Processing at DPS and/or Tag Agency is subject to Cowboy Driving Academy's schedule on the day in question).
- Student has 1 (one) year from the first day of class to complete driving instruction and road exam. A REINSTATEMENT FEE OF \$50 WILL BE CHARGED FOR FINISHING THE PROGRAM AFTER THE 1 (one) YEAR TIME PERIOD.
- For students under 18 years old, this contract must be signed by student and parent or legal guardian and turned back into Cowboy Driving Academy by 2nd day of class. STUDENT WILL NOT BE ABLE TO SIGN UP FOR DRIVE TIMES UNTIL SIGNED CONTRACT IS RECEIVED.**
- NO REFUNDS**

To the extent permitted by law, student and parent or legal guardian agree to indemnify and hold harmless Cowboy Driving Academy from any and all damages, expenses, fees, fines or other amounts occasioned by the acts of student at any time.
